## **CISO Cove with Dave Phillips**

### **OSHEAN's Chief Information Security Officer**

It's no secret that today, cybersecurity threats are more prevalent than ever. Businesses, regardless of size or industry, must take proactive steps to protect sensitive data and maintain trust—both internally and with customers. One of the most effective ways to achieve this is by adopting cybersecurity frameworks. When approached correctly, compliance with these frameworks strengthens our defenses against cybercriminals.

These frameworks serve as both a starting point for securing information and a way to assess the maturity of existing cybersecurity programs.

Take the NIST Cybersecurity Framework (CSF 2.0), for example. Its development involved input from hundreds of stakeholders across industries, government agencies, and academic institutions. Why wouldn't we leverage the collective knowledge, insight, and experience embedded in this or any relevant framework to strengthen our organizations?

Yet, the term "compliance" seems to trigger resistance. In my experience, whether building cybersecurity programs internally or consulting for organizations, I've noticed hesitation around the word and the efforts associated with it. Does "compliance" feel restrictive? Would "adoption" be a better way to frame it?

When I think about compliance with a cybersecurity framework, I see it as a blueprint for implementing and maintaining a strong security program—not just a checklist to meet the bare minimum. True adoption means striving for as close to 100% compliance as possible, continuously improving, and even progressing to more advanced frameworks like NIST 800-53 or 800-171.
